## **Disclaimer for ASC Framework for Rebooting Country Shows**

**The Agricultural Societies Council of NSW (ASC of NSW), the peak body for agricultural shows in NSW, has developed the following guidelines as a resource for its members to utilise following the COVID-19 CRISIS, and its unprecedented impact on holding events.**

**This COVID-19 Framework document (the “Framework”) is intended to provide information to those involved in the organising, and holding of Agricultural Shows, as well as for other interested parties to assist in the decision-making process for organisations and holding of events for our members. However, this Framework is not intended and is not designed to serve as the absolute definition of what must be implemented across the entire membership base that the ASC of NSW represent. Any recommendations outlined in this Framework relate only to the period during which restrictions are placed by the Government to combat COVID-19.**

**The ASC of NSW makes every effort to present accurate and reliable information for its members. Information provided in the Framework is “as is” without any warranty of accuracy, reliability, or otherwise, either express or implied. This document has been designed to be a rough outline, subject to discussion and adjustment as needed. If government (both State and Federal) guidance is more stringent than this document, you should always follow government guidance.**

**The document provides 2 levels of recommendations:**

- 1) A General Level of Recommendation: Refers to practices and procedures that regardless of what the event is, should be undertaken, and,**
- 2) A Specific Level of Recommendation: Refers to practices and procedures that are event specific.**

**Both levels work in conjunction with each other, and with the wider levels of restrictions and health directives from relevant authorities.**

**COVID-19 will be with us for some time, so it is important that Show Societies have a plan- and continue to plan – to keep our committees, our communities and our patrons, healthy, safe and virus free.**

## Introduction

### Principles for Rebooting Country Shows

1. The resumption of New South Wales Agricultural Shows and their correlating activities can contribute many economic, social and cultural benefits to communities currently struggling with the after-effects of natural disasters and the COVID-19 crisis, however resumption of these activities should not compromise the health or safety of individuals or their communities and stakeholders.
2. All decisions about the resumption of Agricultural Shows and their correlating activities must take place with reference to these Principles and must follow the relevant restrictions and conditions as directed by government and health authorities.
3. All information provided by the relevant government and health authorities supersedes any recommendation outlined in this document.
4. The Framework for Rebooting Country Shows provides a guide for the reintroduction of Agricultural Shows and their correlating activities, including Pavilion and Livestock competitions, static displays, and other events organised by members of the ASC. The Framework acknowledges the differences between the various competitions, competitors and individuals who participate in, and contribute to Agricultural Shows.
5. If a Show Society holds events outside of the activities listed within this document, they must refer to the current Federal, State and local health directives plus those that may be imposed by their governing body prior to the re-introduction of these non-listed events.
6. All sub-contractors must provide their own risk management (inclusive of sanitisation etc) to the Show Society prior to being accepted to participate in any of the Agricultural Show Societies events. 7. A detailed register of names and contact details for all that are on the Showgrounds must be kept. A COVID-19 Attendance Register Template can be found as part of this Framework.
8. This Framework is to be considered the recommended minimum standard required to be met and should be introduced alongside Show Societies Risk Management and Biosecurity plans. A COVID-19 Risk Assessment and Management Plan template can be found as part of this Framework.
9. If an organisation or an association looks at seeking specific exemptions in order to recommence activity, particularly with regard to competitions, they are required to engage with, and where necessary seek approvals from, the respective State/Territory and/or Local Public Health Authorities regarding additional measures to reduce the risk of COVID-19 spread and discuss any possible exemptions with the Agricultural Show Societies Council and their relevant Group Executives.
10. Localised outbreaks may require organisations to again restrict activity and those organisations must be ready to respond accordingly.
11. The environment in which events would be held, should be assessed to ensure precautions are taken to minimise risk to those participating in, and those attending, any and all events as spectators (where and when permissible).
12. Signage should remind all volunteers, staff, sub-contractors, and patrons that they have a responsibility not to attend if they are ill, to maintain social distancing and to regularly wash their hands. Please see <https://www.safeworkaustralia.gov.au/doc/signage-and-posters-covid-19>
