# Suggested Wording for Show Schedules

#### **PESTIVIRUS (BOVINE VIRAL DIARRHOEA VIRUS)**

- Cattle must not be exhibited unless tested for Pestivirus and certified as non-Persistently Infected (PI) cattle.
- Certification of testing and proof of non-PI status will be required at the time of Entry in the form of a signed Veterinary Certificate or Laboratory Report, listing animals and their identification. The Cattle Section will verify testing results.
- A National Cattle Health Declaration must be completed for all cattle attending your show. A copy of the declaration is available on the website or via this link.
- This form also confirms, among other things, Pestivirus Vaccination.

Members from Queensland Ag Shows delivered an interesting program with our very own Nicky Seeto presenting on social media which was very well received. We look forward to meeting with the Showmen's Guild at the Sydney Royal Easter Show (SRES) on Friday 22 March.

Following Think Tank, the 2024 AgShows Wheat Dinner was held in Dubbo. The dinner celebrated twenty-five years of the competition and remembered the contribution of the late Tom Dwyer. Congratulations to Rob & Mandy Taylor from Grenfell who were announced the State winner of the Dryland Field Wheat competition. Mickan Bros from Walbundrie received the TJ Dwyer Farming Excellence Award. Thanks also to all our sponsors for their continued support.

The seven Zone Finals of The Land Sydney Royal AgShows NSW Young Woman competition have been held over three weekends in February. Our thanks to Zone hosts Grafton, Penrith, Adelong, Tamworth, Lithgow, Narromine and Temora Show Societies all of which delivered excellent events. Appreciation to all the judges who were tasked with the difficult decision of selecting finalists from such a high-quality list of entrants. Almost 100 hundred young women participated in the Zone Finals with fifteen young women headed to the SRES as State finalists. AgShows NSW is hosting a dinner for the finalists on Wednesday 20 March with the announcement held at the Sydney Showground Amphitheatre on Sunday 24 March. I hope to see many of you there in support.

The Young Judges and Paraders from across NSW will be competing at the SRES with many of the AgShows NSW Directors supporting the program as stewards. The State winners will attend the National Finals in Melbourne later in the year. The judging of the RAS/AgShows NSW Sheep Fleece Country Show Champions class, the RAS/AgShows NSW Wool Article Garment and the RAS/AgShows NSW Rich Fruit Cake will also be judged at the SRES.

Following the success of the Celebrating Ag Shows 2023, we will return to Dubbo on the 31 May and 1 June 2024 to hold another excellent event under the theme – Educate, Motivate & Celebrate. The format will be the same as in 2023 with AgShows NSW Next Gen hosting the welcome drinks on Friday night, a great conference program over the course of the Saturday followed by our AGM and the Gala Dinner with the presentation of our annual AgShows NSW Awards. The Board has determined to continue to hold this annual event for members, and we are looking to put the 2025 event on in Armidale.

The Crown Lands Management Act 2016 is undergoing a 5-year statutory review. With most Shows being conducted on Crown Lands it is important that we use this opportunity to voice our concerns about the recognition of Showgrounds and the historic use by shows and their ongoing tenure. Advocacy expert company, Sefton's, has been engaged to help AgShows NSW formulate a submission to the review and support members who choose to provide their own submission. Submissions close at 11:59pm on 19 March. We encourage Shows to make their own submissions and complete our <u>online survey</u> to help us understand your current challenges with the Crown land Act.

# **NSW Chainsaw Racing Rules - Competition Regulations**

All racing events scheduled up to and including 30 June 2024, shall operate under the AgShows NSW Chainsaw Racing Competition rules updated September 2023.

Chainsaw Racing Rules and Regulations - updated September 2023

All racing events occurring after 30 June 2024, will be governed by the AgShows NSW Chainsaw Racing Competition Rules updated November 2023.

Chainsaw Racing Rules and Regulations - updated November 2023

This decision has been made to ensure a smooth transition between rule sets and to uphold the integrity and safety of our chainsaw racing events.

#### **Insurance Declarations**

Insurance declarations have been sent to all Shows – it's important to complete the declaration and return it to AgShows NSW by **15 March 2024**.

#### Important Insurance Reminder

#### Make sure all your Show activities are covered!

Before holding your Show, it is critical to ensure that all the activities you intend to hold are covered by insurance, otherwise your activity may not be covered, and your Show Society is at risk of being held liable if negligence occurs.

To check if you're covered, you need to check your intended activities against the **2023-2024 Activities List** . This list is your "**Insurance Bible**" when it comes to your insurers' response in relation to your events/activity program.

#### Activities remain categorised as follows:

**CATEGORY A -** These Activities are automatically insured by the underwriter/insurer when run by the Show Society or another entity for no fee.

**CATEGORY B** - The insurer assumes these Activities are being run by a Third Party who have their own insurance (with a copy sighted of their certificate of currency). Please note certain activities require the Show Society to be noted as an interested party on the third party's insurance certificate. If the Show Society is running these Activities without a third party, you must email AgShows NSW <a href="mailto:asc.admin@ascofnsw.org.au">asc.admin@ascofnsw.org.au</a> to seek confirmation from the underwriter/insurer that they will cover the activity.

**CATEGORY C -** These activities are uninsured.

**CATEGORY D -** These activities are subject to

- Competition Peak Body Rules and Regulations or
- INSURER APPROVED Rules & Regulations or
- An insured Third Party run the Event.

Numerous activities and competitions are subject to peak body or Insurer approved rules and regulations. It is important that you comply with these Rules and Regulations as non-compliance or deviation from approved rules and regulations means your event may not be insured. This means that your Show Society would be liable if negligence occurs.

Please note "Stockman's Challenge Competitions/Training" and "Young Farmers' Challenge" will require insurer's prior approval, with provision of a list of activities submitted.

What do you if your activities do not appear on the Activity List, or you are unsure if you're covered?

Please seek confirmation from the underwriter/insurer that they will cover the Activity by emailing <a href="mailto:asc.admin@ascofnsw.org.au">asc.admin@ascofnsw.org.au</a>. Unless this activity is approved, it will not be insured.

Failure to seek confirmation of coverage where required (see explanations above) may result in your Activities not being covered by insurance.

# **Insurance Program 2024/2025**

Members need to prepare for increased insurance costs. The latest forecast we have from our insurance broker is to expect increases in insurance costs across the following insurance categories:

- Public & Products Liability 7.5-10%
- Industrial Special Risks 5-10%
- Association Liability 20-25%
- Voluntary Workers 2-3%
- Goods in Transit 0-2%

Once we have the insurance declarations in, PSC (our brokers) will be able to negotiate the best and most affordable outcome which protects our Shows, the Show Society Executive and Volunteers, our property, livestock, and the public.

AgShows NSW invests resources and professional service fees to ensure the

State-wide insurance program offered to members offers the highest levels of protection and assurance at the best price. We have been subsidising the insurance program for many years, covering all brokerage and administration fees as well as subsidising Associations Liability premiums. Over time, this subsidy has become considerable.

After careful consideration by the Board, the full cost of Association's Liability insurance will be passed onto Shows as well as a share of brokerage costs. AgShows NSW will still offer subsidies to cover Group insurance and to ensure Payment plans will still be available to members by contacting the office.

The current Demolition Derby Rules need to be revised/updated. AgShows will review and provide a draft copy to our members for a membership feedback phase. The new rules will be distributed and posted on our website at the conclusion of this phase and following insurer approval.



# **Show Safety Officer Position Description**

Reports to: Show Secretary Financial delegation: Nil Key Accountabilities:

- \* Support the development of "Name" Show's WHS policies and programs
- \* Ensure Annual show's risk management plan is updated and provide to the Show Secretary one month prior to show dates
- \* Advise and instruct the Show committee via the Show secretary on various safety-related topics (noise levels, use of machinery etc.)
- \* Conduct risk assessment and advise on preventative measures
- \* Review existing policies and measures and update according to legislation
- \* Initiate and organise WHS training of employees and executives where required
- \* Inspect show ground and the work of personnel to identify issues or nonconformity (e.g. not using protective equipment)
- \* Oversee installations, maintenance, disposal of substances etc
- \* Liaise with Showmen's Guild WHS Office
- \* Liaise with any special attraction exhibitors for main show ring e.g. fireworks, Car/ motorcycle demonstration for special safety precautions
- \* Regular walk-throughs of all show areas and sideshow alleys
- \* Stop any unsafe acts or processes that seem dangerous or unhealthy
- \* Record and investigate incidents to determine causes and handle worker's compensation claims
- \* Prepare reports on occurrences and provide statistical information to Show secretary

#### **Physical Aspects of Safety Officer:**

Physical aspects of the position include but are not limited to the following:

- \* Constant standing and walking throughout shift
- \* Frequent lifting and carrying up to 10 kg's.
- \* Occasional kneeling, pushing, pulling, lifting
- \* Occasional ascending or descending ladders, stairs, and ramps

- 1) When paying ALL invoices, it is imperative that you contact your supplier and confirm their invoice details and bank details BEFORE you pay every invoice. Use contact details on the website or other means, not the contact details on the invoice.
- 2) When receiving unsolicited phone calls seeking information about your bank account, please hang up and contact your bank directly.

# **Cyber Security Checklist**

#### Ten tips from your Insurance Broker on how to reduce cyber threats/risk

Adhering to a Cyber Security Policy is crucial to protecting all shows from cyber phishing risks and to safeguard company funds. The prevalence of cyber-attacks is on the rise and extra diligence is now required.

Here are 10 easy points to help protect show's financial assets in today's cyber risk environment.

#### 1. Verify the Caller's Identity:

If inbound calls are unsolicited, ask for the caller's name, organization, and contact information. However, keep in mind that scammers can provide fake information.

#### 2. Do Not Share Personal or Show Information:

Avoid sharing personal or financial information over the phone or email, especially if you did not initiate the call or email. Legitimate organizations will not ask for sensitive information such as passwords or Social Security numbers over the phone.

#### 3. Hang Up:

If you are unsure about the call, it's okay to hang up. You can also delete the email. You can then independently verify the author's / caller's identity through official channels.

#### 4. Call the Official Number:

Use official contact information obtained from the organization's official website or other reliable sources to call them back. Do not use the phone number provided by the caller.

#### 5. Secure Financial Transactions:

Please establish a strict verification process for any changes to payment details or financial transactions. Where appropriate, use secure and encrypted payment gateways for all financial transactions.

#### 6. Never click on any links in unsolicited or unknown emails:

Always enquire with the official organisation about the legitimacy of their enquiry. Right mouse click on the author's email to reveal the originating email address (if hidden) and see if it is from the official company email address. Often threat actors disguise the originating email address to avoid suspicion.

#### 7. Show Volunteer / Employee Training and Awareness:

Conduct regular training sessions for relevant volunteers / employees to educate them on phishing risks. Raise awareness about the latest phishing techniques and tactics. Test knowledge where appropriate to ensure they can identify and report suspicious emails.

#### 8. Use Multi-Factor Authentication (MFA):

Implement MFA for all systems and applications where appropriate, especially those related to financial transactions. Ensure that relevant volunteers/employees use strong, unique passwords in conjunction with MFA.

#### Email Filtering and Authentication:

Employ advanced email filtering systems to detect and block phishing emails. Implement email authentication protocols such as DMARC (Domain-based Message Authentication, Reporting, and Conformance) to prevent email spoofing.

#### 10. Regular Software Updates and Patching:

Ensure that all software, including operating systems, antivirus, and anti-malware solutions, are regularly updated with the latest security patches.
