This Award is for innovation by a Show Society Member of the Agricultural Societies Council of NSW Ltd. Anything you feel your Show Society has done that is innovative will be considered. For example, an event, a marketing advertising, innovative use of technology, procedural changes, environmental practices, that you feel have taken your Show Society or many Show Societies to the next level.

### Terms & Conditions

- Your innovation must be fully operational now and have been developed within the period 1 January 2020 to 31 December 2020.
- Finalists will be announced to all ASC Members via email.
- The winner of the President's Innovation Award will be announced at the Annual General Meeting to be held at the end of May 2021.
- The other 2 Finalists will receive a Plaque at the Annual General Meeting.
- The President's Innovation Award Winner will receive a plaque along with a cheque for \$3,500 to be used for a development or project that will benefit the winning Show Society.
- The nominee Societies must be Members in good standing of the Agricultural Societies Council of NSW Ltd. This is NOT an award for individuals.
- Groups are not eligible to enter for this award.
- The nomination must be signed by any 2 of: President, Secretary or Treasurer of your Show Society.
- The Judging Panel will be the ASC's Executive Committee.
- The Award will be at the ASC Executive Committee's discretion with the ASC Executive Committee's decision being final
- The innovation cannot be because of a grant received.
- Please submit documentation, illustrations and/or photography and other records of your innovation.
- **Please note all applications must be received at the ASC office by the close of business on Monday, 19 April 2021.**
